Purpose

The purpose of this document is to provide a catalogue containing details of all standard CRIS Training courses available.

Audience

This document is intended to be used by existing and prospective customers.



Core CRIS Cascade Training for New Installations

The Core CRIS Cascade Training Session is designed to prepare a maximum of 8 delegates who will be responsible for undertaking training or deploying the CRIS system. The course takes place in two parts over a 2 - 3-week period 8 – 9 weeks prior to Go-Live. Part 1 covers Standard Front-End Modules/Usage over a 2-day duration, whilst Part 2 introduces System Management & Statistical Reports in addition to an end of course Workshop and Assessment Day over a 3.5 day duration. The course cannot be changed to run consecutively as the break between weeks is specifically designed to facilitate essential delegate consolidation between Parts I and II.

This course is aimed at Key Stakeholders including System Champions, System Administrators and Cascade Trainers.

Detailed Introduction to Core CRIS

The Detailed Introduction to Core CRIS training course is available for existing CRIS customers looking to upskill Key Stakeholders including System Champions, System Administrators and Cascade Trainers who do not have previous experience of the CRIS system. The course takes place in two parts over a 2 - 3 week period. Part 1 covers Standard Front-End Modules/Usage over a 2-day duration, whilst Part 2 provides detailed System Management and Statistical Reports Training over a 2.5 day duration. The course cannot be changed to run consecutively as the break between weeks is specifically designed to facilitate essential delegate consolidation between Parts 1 and 2.

Core CRIS End to End System Workflow Seminar & Best Practice Workshop

This session provides a comprehensive End to End Core CRIS System Workflow demonstration which enables delegates to participate in an interactive seminar / best practice workshop that is designed to ensure that all participants are fully aware of all recommended Core CRIS System functionality contained within the latest release of software which they are either currently using or intending to upgrade to / deploy in the near future.

Even if the Customer has been using CRIS for years - long term, existing CRIS users are not always familiar with all features of their current install or would welcome the opportunity to further discuss existing functionality in terms of establishing correct usage, improving workflow, and increasing efficiency and productivity.

The target audience for this session is RIS / PACS System Administrators, and Clinical and Clerical Leads from the Radiology Department.

This is a very popular sessions with existing customers who are typically looking to:

- Confirm recommended workflows, make improvements to existing system usage, and increase efficiency and productivity.
- Upgrade to the latest version of CRIS and seeking to ensure they are aware of any new feature benefits as well as identifying any areas for improvement on existing, or future ways of working.
- Customers involved in Trust mergers or moving to consortium wide solutions with other CRIS Trusts.

This session is also aimed at customers who often express the feeling that "they don't know what they don't know" as it provides the opportunity to assess recommended system workflow against existing local working practice and facilitates an interactive training needs analysis or system usage health check from which to identify future formal Training Requirements or Application Specialist Consultancy.

Core CRIS Inclusive and Additional Modules Training

CRIS Inclusive and Additional modules are typically scheduled Post Go-live in order to enable the Customer to deploy Core system functionality ahead of introducing new modules which either involve considerable changes to existing working/business processes, or alternatively will only be used by a minority of users and therefore do necessitate any priority pre go-live.

Exceptions to this are the VETTING and OBSTETRICS ULTRASOUND modules which can be scheduled pre go-live upon demand via additional days in conjunction with Core Cascade Training.

- Vetting Module
- Resource Module

- Sessions Module
- Obstetric Ultrasound Module (Standard Forms)

Training for all Inclusive Modules training is typically delivered as 2 x ½ Day sessions per module as follows:
